**REGISTRATION FORM**

I, \_\_\_\_\_ agree to participate in the Fund Raising Cruise with the Girdletree Volunteer Fire Company, Inc. with Carnival Cruise Lines on the Carnival Pride departing Baltimore, Maryland on Sunday, March 27, 2011. With ports of call of Port Canaveral, Florida and Nassau and Freeport, Bahamas. The cruise concludes on Sunday, April 3, 2011. I understand a Passport is not required to be a passenger on this cruise, but is preferred. If I don't use a Passport each member of my party must have a certified birth certificate and government photo identification. All Carnival FunPass data must be completed within 60 days of booking. I understand I have two options for payment of this cruise. I also understand I must book through the Girdletree Volunteer Fire Company and the cruise rate is based on double occupancy. The payment types and dates, as explained, are as follows.

1) **STANDARD REGISTRATION:** An initial deposit of \$25 per person/\$50 per cabin is required with this registration form. A minimum deposit of \$500 per cabin (\$250 per person) is required by Thursday, October 7, 2010. With the balance of the cruise due on Tuesday, January 4, 2011.

\_\_\_\_\_ I accept the terms of this cruise registration and have read and understand Carnival's Cancellation Policy.

2) **GIRDLETREE PAYMENT EXTENSION PLAN:** An initial deposit of \$25 per person/\$50 per cabin is required with this registration form. There will be up to nine (9) monthly payments of a minimum of \$150 due the first of every month starting in July 2010 and ending in March 2011. The balance (Up to \$300) will be due on Friday, March 11, 2011. There are no fees or interest charged for the payment extension plan. Carnival's standard cancellation policies will apply. The only penalties for the payment extension plan are as follows. 1) For every payment due on the 1<sup>st</sup> of the month and not paid by the end of the business day on the 5<sup>th</sup> of the month (the 3<sup>rd</sup> or the 4<sup>th</sup> if the 5<sup>th</sup> occurs on the weekend), a cash penalty of \$25 per cabin will be assessed and will be added to the late payment. Late payments of more than 31 days will constitute forfeiture. Refunds for cabin payments whose payments were more than 31 days late will be at the discrepancy of the Fire Company, more so the Fund Raising Committee. The total paid for payment extension plan is \$1,400. Payments consist of the initial deposit of \$50 and 9 payments of \$150. The remaining \$300 balance is due and must be paid in full by March 11, 2011.

- For special 3/4/5th guest rates, if the cancellation penalty exceeds the rate, the penalty will be equivalent to that rate. Reservations will be held until 30 minutes prior to departure without risk of automatic cancellation.
- No refunds will be made in the event of "no shows". We recommend the purchase of trip cancellation insurance.
